an initial \$2.25M gift from the Bruner Foundation building on 34 years of work on the Rudy Bruner Award for Urban Excellence.

PROFESSOR 1982-date; CHAIR in Architecture 1982-1990; and DEAN 2011-date. SUNY DISTINGUISHED PROFESSOR, 2021 - date. During the service as Dean and chair, the units grew, expanded research expenditures, and increased annual giving and endowed philanthropy. Two of three facilities were fully renovated, with one more scheduled for completion over the next three years.

FOUNDING DIRECTOR, THE URBAN DESIGN PROJECT (UDP) 1990-2011, DIRECTOR, THE UB REGIONAL INSTITUTE (UBRI) 2011-2015, and Fellow (1996 to date). He led the UDP, developing an award-winning ensemble of plans for Buffalo's downtown, waterfront, Olmsted park system, and city-wide comprehensive plan. In 2011, Shibley aligned UDP with UBRI, a planning and policy research center. Under his leadership, the enterprise, branded as UBRI, provided research, public engagement, urban design, and planning for the region, including work on the Western New York (WNY) Regional Economic Development Council's strategic plan and their "Buffalo Billion" investment plans.

Shibley was the principal investigator guiding *One Region Forward*, a federally recognized plan for sustainable development in Erie and Niagara Counties. The plan won national awards from the American Planning Association (APA), the Lincoln Land Institute, and the Association of Collegiate Schools of Planning.

CAMPUS PLANNER AND ARCHITECT 2006-date. As Senior Advisor to the President, he developed *UB 2020: The Comprehensive Physical Plan* and now serves as UB's Campus Architect, advising on plan implementation. He chaired UB's Environmental Stewardship Committee, producing the University's first adopted Climate Action Plan seeking a carbon-neutral campus by 2030.

AUTHOR. Shibley co-authored 17 books, including *Placemaking: The Art and Science of Building Community, Urban Excellence,* and *Time Savers-Standards for Urban Design.* He also authored or co-

authored 14 book chapters, 14 U.S. government publications, and over 100 articles in professional and academic presses. His UDP published forty plans and reports, and with UBRI, he added over fifty more.

STATE AND FEDERAL SERVICE. With the Governor's nomination, Shibley served on the N.Y. State Fire Prevention and Building Code Council (2001-2005). He was a Federal Commissioner on the Erie Canalway National Heritage Corridor (2006-2011) nominated by U.S. Senator Hillary Rodham Clinton. Before his UB appointment, he was a project architect for the U.S. Army Office of the Chief of Engineers (1971 to 1980). In this position, he earned the Department of Defense Meritorious Service Medal for participating in "the greatest advances in the improvement of design criteria and methods in the history of the Corps." He also managed research and development with the U.S. Department of Energy as Branch Chief in the Passive and Hybrid Solar Energy Division (1980-1981).

AWARDS. Professor Shibley has 20 lifetime achievement awards from national (8) and regional/local (12) institutions. The American Institute of Architects (AIA) presented Shibley with the 2014 Thomas Jefferson Award for Public Architecture, and he was elevated to the AIA College of Fellows in 2011, receiving parallel recognition from the APA through his induction in the American Institute of Certified Planners (AICP) College of Fellows in 2015. In 2016 he was named one of the 25 most admired architecture and design educators by *DesignIntelligence*.

He also received the James R. Haecker award for leadership from the Architectural Research Centers Consortium and the UB President's Medal. The Catholic University of America recognized him as a distinguished Alum and the NY State AIA recognized him with the 2014 Nelson A. Rockefeller Award for Public Architecture and the 2013 Educator of the Year Honor Award. The Upstate Chapter of the APA awarded him the Michael J. Krasner Professional Planner Award for Distinguished Leadership. The Buffalo Western NY Chapter of the AIA awarded the Robert and Louise Bethune Award in November 2012 for a lifetime of professional service. Shibley also led professional project work with faculty and students resulting in over 18 international/national awards and 20 regional/local professional awards.

SUNY Distinguished Professor (2021 to date)

Dean (2011 to date). During his term, the School sustained accreditations with distinction in Urban and Regional Planning and Architecture. Enrollment grew about 20%, with the largest growth in graduate programs. Research and sponsored program dollar awards grew by over 300%, aided by six new research and sponsored program units. Philanthropy tripled, and the endowment grew by a factor of 10. Significant gifts were increased by over 200%, and annual contributions approached 300%. The School completed the historic restoration of its home, Hayes Hall, and companion studio building at Crosby Hall. It also developed substantial advances in the inclusiveness of its faculty, staff, and student body. It added new academic programming in global health, preservation, and real estate development and joint programming with Law, Management, Education, Engineering, and the College of Arts and Sciences. The School completed its first decade of a new Ph.D. in Planning. It has responded positively to two exhibit invitations from the European Cultural Centre during the Venice Architecture Biennale with Global Arts Affairs. The School took three first-place and two second-place finishes in the U.S. Department of Energy Solar Decathlon of 2015, with a second-place finish overall.
